



## Resurrection Lutheran School Chromebook Use Agreement

In an effort to help our students reach their full educational potential Resurrection Lutheran School has implemented Chromebooks in many of its classrooms. These devices will be issued to the students on an annual basis for use throughout the school day. In some cases, students will be allowed to take them home.

I understand that, at all times, legal title to the equipment is maintained by Resurrection Lutheran School and is being loaned to the student for educational purposes for the academic school year.

The student's right of possession and use is limited to and conditioned upon the student's complete compliance with this agreement and the Acceptable Use of Technology Policy.

### **Student Agreement**

As a student, I agree that I will:

- Use my Chromebook for educational purposes.
- Follow the procedures and policies outlined in the Resurrection Lutheran School Acceptable Use of Technology Policy.
- Protect my Chromebook by carrying it securely to prevent careless or malicious damage.
- Never leave my Chromebook unattended in an unsecure or unsupervised location.
- Return my Chromebook to the classroom cabinet to charge my Chromebook's battery to full capacity each night.
- Promptly report all damages to or issues with my Chromebook to a Resurrection staff member.
- Not alter or attempt to change the management settings on my Chromebook or delete school-supplied software.
- Never share my Chromebook with other students or individuals.
- Not apply any marks, stickers, or other decorations to my Chromebook.
- Maintain the equipment in a manner to protect it from harm, including: not leaving the equipment exposed to direct sun for extended periods of time; avoiding dropping, throwing, or otherwise recklessly handling the equipment; not using the equipment in close proximity to food or drink, or otherwise placing the equipment in proximity to substances, such as liquids of any sort, potentially harmful to the equipment.

**I understand that any violation of this agreement may result in the suspension or loss of my Chromebook and school network privileges. Additionally, I may face disciplinary action for such violations.**

**Parent Agreement**

I understand that my family’s responsibilities include:

- ▣ Ensuring my child meets the expectations outlined in the Resurrection Lutheran School Acceptable Use of Technology Policy.
- ▣ Encouraging my child to properly protect the Chromebook, within reason, against damage, loss or theft while it is at school.
- ▣ Ensuring my child reports damage to a staff member promptly.

**Financial Responsibility**

Resurrection Lutheran School will provide coverage for Chromebook repairs or replacement in the event of accidental damage. For each incident, parents will be charged a modest \$25 deductible.

Resurrection Lutheran School will not provide coverage for Chromebook repairs or replacement in the event of intentional damage. For each incident, parents will be responsible for reimbursing the school for repair or replacement costs.
